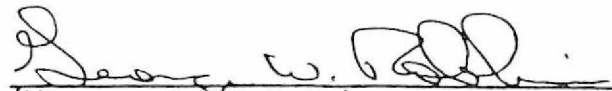

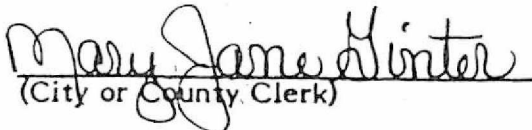

WHEREAS, this resolution is part of the application process for solid waste management area designation;

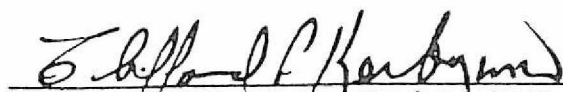

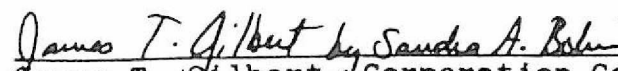

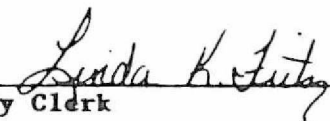
