

RESOLUTION NO. 04-08

A RESOLUTION OF THE MADISON COUNTY FISCAL COURT, KENTUCKY PURSUANT TO KRS 198B AND THE KENTUCKY BUILDING CODE TO ESTABLISH MECHANICAL PERMIT FEES FOR THE INSTALLATION, REPLACEMENT OR ADDITION OF HEATING, VENTILATION, AND AIR CONDITIONING SYSTEMS IN MADISON COUNTY, KENTUCKY.

WHEREAS, the General assembly enacted KRS198B.650 to 198B.689 to regulate a license heating, ventilation and air conditioning contractors; and

WHEREAS, KRS198B.688 requires the installation, maintenance, alteration or repair of heating, ventilation and air conditioning systems to be made in accordance with the Uniform State Building Code; and

WHEREAS, Section 105 of the Kentucky Building Code currently requires a permit to be issued for the installation, maintenance, alteration or repair of heating, ventilation and air conditioning systems; and

WHEREAS, KRS 198B.060(18) authorized local governments enforcing the Kentucky Building Code to establish a fee schedule to fully cover the cost of the functions performed pursuant to KRS Chapter 198B;

NOW, THEREFORE BE IT RESOLVED, by Madison County Fiscal Court that the fee schedule for the mechanical permit to be issued for the installation, maintenance, alteration or repair of heating, ventilation and air conditioning systems shall be as follows:

SECTION I

Single Family Residential	\$25.00
Multi-Family Residential	\$25.00 per dwelling unit
Commercial	\$50.00 per tenant space
Churches and other similar religious buildings	\$50.00
Industrial Buildings	\$75.00
Schools	\$75.00

SECTION II

That no Mechanical Permit shall be issued for the installation, maintenance, alteration or repair of heating, ventilation and air conditioning systems until the applicant has paid to the Planning and Development Office a fee according to the approved schedule, and provided a copy of the required State HVAC License;

SECTION III

That the County Clerk causes this Resolution to be published in accordance with the appropriate Kentucky Revised Statutes.

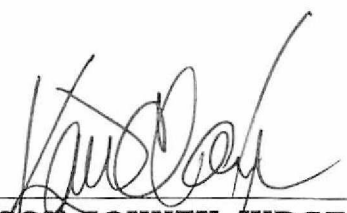

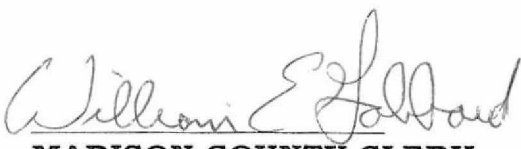
