

RESOLUTION 11-04

A RESOLUTION AUTHORIZING THE GIS STAFF OF THE BLUEGRASS AREA DEVELOPMENT DISTRICT TO UPDATE THE COUNTY ROAD DATABASE AT THE KENTUCKY TRANSPORTATION CABINET TO INCLUDE VARIOUS ROAD ERRORS IN THE NAMING OF MADISON COUNTY ROADWAYS

WHEREAS, the GIS Staff of the Bluegrass Area Development District, as part of the County Rural Aid program, has been working with the local officials in Madison County to update the county road database at the Kentucky Transportation Cabinet. In this process, there were errors discovered in the names of a few roads that need correcting; and

WHEREAS, the corrections needing to be changed are as follows:

- 1) Mule Shed Road needs to be correctly changed to Mule Shed Lane; Crutcher Pike from Barnes Mill Road to Mule Shed Lane was incorrectly mapped as Mule Shed Lane; the road segments from Barnes Mill Road to Mule Shed Lane need to be correctly changed to Crutcher Pike;
- 2) Mill Stream Drive and Timberlake Drive were incorrectly mapped as a single road off of Hagan Mill Road; the first segment off of Hagan Mill Road needs to be correctly changed to Mill Stream Drive; the second segment that is mapped to the right of Mill Stream Drive needs to remain as Timberlake Drive;
- 3) the Street type in Finney Fork needs to be spelled out and the road name correctly changed to Finney Fork;
- 4) Rowlette Drive needs to be correctly changed to Rowlette Lane;

WHEREAS, the proposed GIS map of these corrections are attached as Exhibits #1,2,3,4,& 5

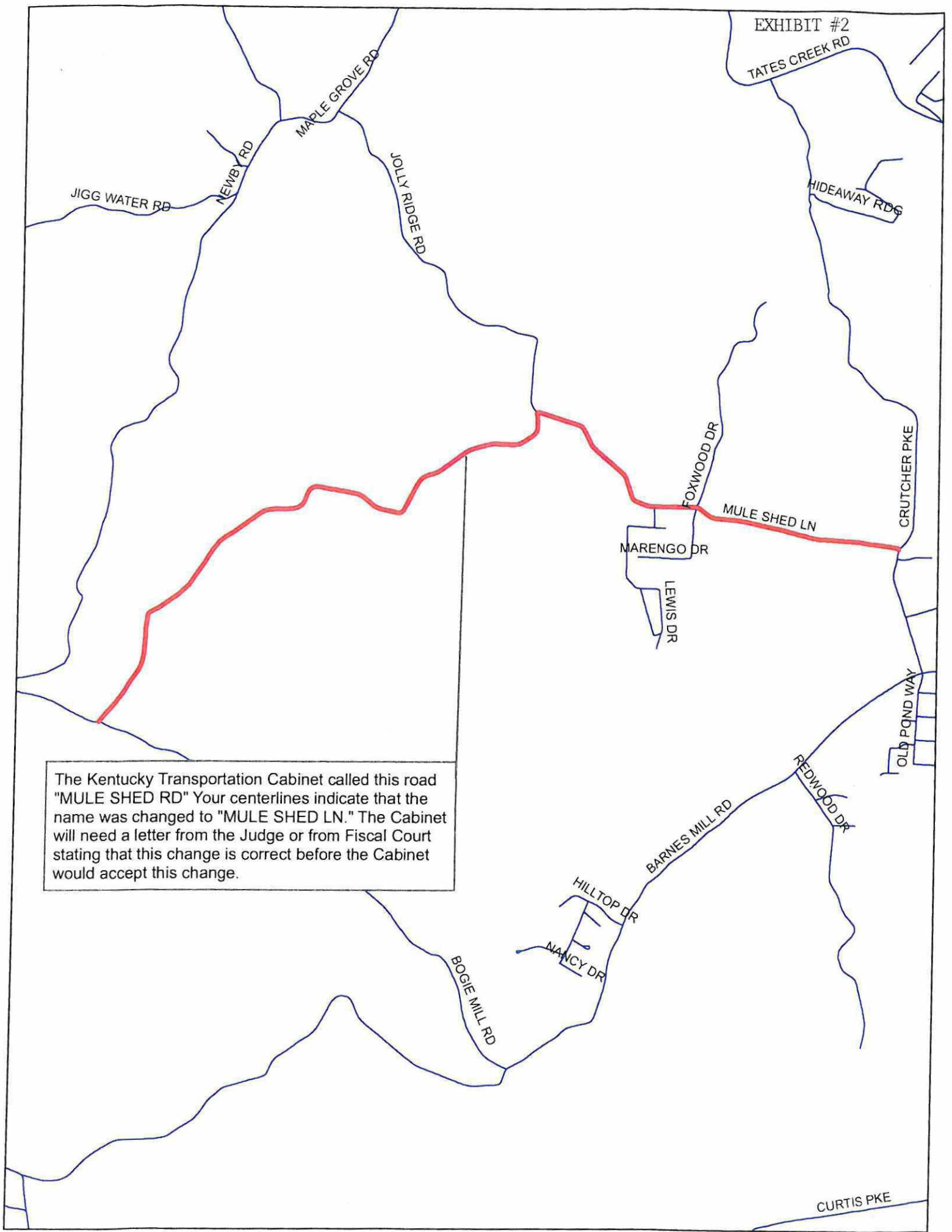

The Kentucky Transportation Cabinet called this entire road centerline "TIMBERLAKE DR." Your centerlines indicate that this is two road centerlines. I split the centerline in two and called the first centerline "MILL STREAM DR" and called the second centerline "TIMBERLAKE DR." The Cabinet will need a letter from the Judge or from Fiscal court stating that this change is correct before the Cabinet would accept this change.
