WHEREAS, Ordinance 99-17 allows for a subdivision within the County Road System to petition the Fiscal Court for a lower speed limit; and

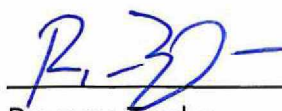

at 15 miles per hour.

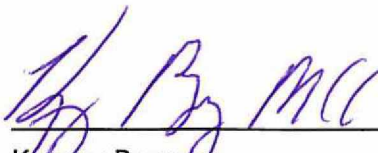
