WHEREAS, a vacancy to the Madison County Cooperative Extension Board is open; and

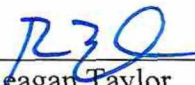
WHEREAS, the Madison County Fiscal Court has found Connie Baird as fit for the position as board member of the Madison County Cooperative Extension Board; and

COOPERATIVE EXTENSION BOARD MEMBER.**

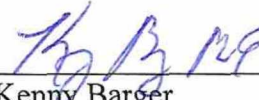
