**A RESOLUTION FOR APPLICATION AND ADMINISTRATION OF KENTUCKY
UTILITIES 2021 PLANT FOR THE PLANET GRANT FUNDS**

WHEREAS, THE 2021 PLANT FOR THE PLANET GRANT ALLOWS UNITS OF LOCAL GOVERNMENT AND OTHER ELIGIBLE ENTITIES TO APPLY FOR FUNDING FOR URBAN, SUBURBAN OR RURAL TREE PLANTING PROJECTS IN FORESTS AND PARKS AND ALONG PARKWAYS OR ROADWAYS WITHIN THE KENTUCKY UTILITIES SERVICE AREA; AND

WHEREAS, THE MADISON COUNTY FISCAL COURT, KENTUCKY, DESIRES TO MAKE AN APPLICATION FOR 2021 PLANT FOR THE PLANET GRANT FUNDS; AND

WHEREAS, THE COUNTY OF MADISON, KENTUCKY, WISHES TO AUTHORIZE THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE TO MAKE APPLICATION FOR THESE GRANT FUNDS, AND IF THE APPLICATION IS SUCCESSFUL, TO ENTER INTO AN AGREEMENT WITH KENTUCKY UTILITIES TO ADMINISTER THESE GRANT FUNDS, TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY TO FACILITATE AND ADMINISTER THE AWARD, TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THE AWARD; AND

WHEREAS, THESE ONE-YEAR GRANTS RANGE FROM \$500 TO \$5,000 AND THE AMOUNT OF GRANT FUNDING MADISON COUNTY WILL RECEIVE (IF ANY) WILL BE DETERMINED BY KENTUCKY UTILITIES ONCE APPLICATIONS ARE RECEIVED; AND

WHEREAS, THERE IS NO LOCAL MATCH REQUIRED.

MADISON COUNTY, KENTUCKY**
