**A RESOLUTION APPROVING A CONTRACT BETWEEN MADISON  
COUNTY FISCAL COURT AND LESLIE COUNTY FISCAL COURT TO HOUSE  
ADULT MADISON COUNTY PRISONERS AT THE LESLIE COUNTY  
DETENTION CENTER IN LESLIE COUNTY, KENTUCKY**

**WHEREAS**, during necessary times, the Madison County Fiscal Court requires the use of other detention centers to provide temporary housing to adult Madison County prisoners; and

**WHEREAS**, Jailer Steve Tussey wishes to enter into a contract with Leslie County Fiscal Court at a rate of thirty-five dollars (\$35.00) per day, for each Madison County prisoner housed at the Leslie County Detention Center; and

**WHEREAS**, the terms of this agreement shall be one (1) year, November 10, 2020 through November 9, 2021.

**NOW, THEREFORE, BE IT RESOLVED THAT THE FISCAL COURT DOES HEREBY APPROVE TO ENTER INTO THE CONTRACT AND AUTHORIZES THE JUDGE EXECUTIVE TO EXECUTE SAME ON BEHALF OF THE COUNTY.**

CONTRACT TO HOUSE ADULT MADISON COUNTY PRISONERS

---

1. Parties.

The Leslie County Fiscal Court (with the consent of the Leslie County Jailer) and the Madison County Fiscal Court (with the consent of the Madison County Jailer) agree to house adult Madison County prisoners at the Leslie County Detention Center in Leslie County, Kentucky.

2. Definition of "Adult Madison County Prisoner".

Any prisoner, eighteen (18) years of age or older, with criminal or civil contempt of court charges pending, originating or disposed of in Madison County.

3. Rate of Pay.

The Madison County Fiscal Court agrees to pay Leslie County Fiscal Court the sum of Thirty-five Dollars (\$35.00) per day, for each Madison County prisoner housed at the Leslie County Detention Center.

4. Calculation of a Day.

The per-day charge shall apply regardless of whether a prisoner is held for twenty-four (24) hours on any given day, or is released immediately after being booked in. The per-day charge will also be defined as which facility feeds the inmate two (2) meals in a twenty-four (24) hour period.

5. Use of Other Jails.

The Madison County Fiscal Court reserves the right to simultaneously contract with any other county to house all or any portion of its prisoners.

6. Refusal of Prisoners.

The Leslie County Detention Center reserves the right to refuse to accept Madison County prisoners under the following conditions:

- 1) When the Detention Center becomes overcrowded;
- 2) When the prisoner is in need of immediate medical or psychological treatment; and
- 3) When the prisoner poses an extreme risk to the security of the Jail.

7. Inmate Billing Invoices.

The Leslie County Detention Center shall submit a monthly inmate billing invoice to the Madison County Fiscal Court, and the Madison County Fiscal Court shall promptly pay the amount due to the Leslie County Fiscal Court.

8. Medical Bills.

The Madison County Fiscal Court shall be responsible for paying the bills of any and all outside healthcare providers incurred by Madison County prisoners, while inmates are housed in the Leslie County Detention Center, including but not limited to the cost of medication, doctor bills, dental bills, hospital bills, ambulance bills, etc.

While Madison County prisoners are housed in the Leslie County Detention Center, we agree to provide the same quality medical care to those Madison County prisoners as is provided to all other county and state inmates held in the facility.

Additionally, Leslie County Detention Center has developed cost-effective relationships with local medical and dental care providers.

9. Medical Co-Payments.

The Leslie County Detention Center shall be allowed to charge Madison County prisoners reasonable medical co-payments, in addition to the amounts charged by outside healthcare providers, in an effort to reimburse the Detention Center for the cost to the Detention Center of providing medical services to Madison County prisoners, including but not limited to the cost of providing in-house nursing services, transportation and security.

10. Medical Transports and Hospital Security.

The Madison County Jail or Fiscal Court is responsible for Madison County inmates to be transported to the hospital or any other facility to be treated, and also if prisoner is admitted in hospital or any other treatment facility, Madison County Fiscal Court is responsible to provide transportation and security personnel to and from the facility.

11. Court Transports and Security.

It shall be the responsibility of the Madison County Fiscal Court to provide transportation and/or security personnel for Madison County court appearances.

12. Effective Date.

This Agreement shall become effective on the 10<sup>TH</sup> day of NOVEMBER, 2020.

13. Termination.

This Agreement can be terminated by either party, by written notice to the other party. Madison County will have up to sixty (60) days from the date of written termination in which to remove its inmates from the Leslie County Detention Center facility.

14. Terms of Agreement.

The terms of this Agreement will last one (1) calendar year, <sup>RT</sup> ~~October~~ <sup>NOVEMBER</sup> 10, 2020, through
