**A RESOLUTION TO AWARD BIDS FOR ROAD AND BRIDGE PROJECTS FOR THE

REPLACEMENT, AND WHEELER BRANCH ROAD SLIDE REPAIR**

ARBUCKLE ROAD SLIDE REPAIR SITE 2 to Hinkle Env. Ser. for \$ 106,203.⁰⁰
HAGAN MILL ROAD SLIDE REPAIR to Hinkle Env. Ser. for \$ 55,182.⁰⁰
ANGEL ROAD BRIDGE DECK REPLACEMENT to Vanhoose Coe Precast for \$ 40,323.⁹⁶
WHEELER BRANCH ROAD SLIDE REPAIR to Hinkle Environmental Ser. for \$ 74,923.⁵⁰
