A RESOLUTION FOR APPLICATION AND ADMINISTRATION OF KENTUCKY JUSTICE AND PUBLIC SAFETY CABINET EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT ("JAG") FOR FEDERAL FISCAL YEAR 2020

WHEREAS, THE KENTUCKY JUSTICE AND PUBLIC SAFETY CABINET IS ACCEPTING APPLICATIONS FOR THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT ("JAG") FOR FEDERAL FISCAL YEAR 2020; AND

WHEREAS, FUNDS AWARDED UNDER THIS PROGRAM MAY BE USED FOR A VARIETY OF JUSTICE AND PUBLIC SAFETY PROGRAMS, INCLUDING ENFORCEMENT, PROSECUTION, CORRECTIONS, TREATMENT, PREVENTION AND EDUCATION; AND

WHEREAS, THE PURCHASE OF PUBLIC SAFETY EQUIPMENT IS ONE OF THE ALLOWABLE USES OF THESE FUNDS; AND

WHEREAS, THE MADISON COUNTY FISCAL COURT, KENTUCKY, DESIRES TO MAKE AN APPLICATION FOR FY2020 KENTUCKY JUSTICE AND PUBLIC SAFETY CABINET JAG FUNDING; AND

WHEREAS, THE COUNTY OF MADISON, KENTUCKY, WISHES TO AUTHORIZE THE JUDGE/EXECUTIVE TO MAKE APPLICATION FOR FY2020 KENTUCKY JUSTICE AND PUBLIC SAFETY CABINET JAG FUNDING, AND IF THE APPLICATION IS SUCCESSFUL, TO ENTER INTO AN AGREEMENT WITH THE KENTUCKY JUSTICE AND PUBLIC SAFETY CABINET TO ADMINISTER THIS AWARD, TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY TO FACILITATE AND ADMINISTER THE AWARD, TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THIS AWARD; AND

MADISON COUNTY FISCAL COURT IS REQUESTING KENTUCKY JUSTICE AND PUBLIC SAFETY CABINET JAG FUNDS IN THE AMOUNT OF \$33,012.50 TO BE EXPENDED DURING THE GRANT PERIOD TO PURCHASE TASERS AND ASSOCIATED EQUIPMENT;

WHEREAS, A TWENTY-FIVE PERCENT (25%) CASH MATCH FROM NON-FEDERAL SOURCES MAY BE REQUIRED; AND

NOW, THEREFORE, BE IT RESOLVED THIS 28th DAY OF APRIL 2020, BY MADISON COUNTY, KENTUCKY

THE JUDGE/EXECUTIVE IS HEREBY AUTHORIZED TO EXECUTE AND FURNISH ALL REQUIRED DOCUMENTATION, INCLUDING MEMORANDUM OF AGREEMENTS, AS MAY BE REQUIRED FOR THE FURTHERANCE OF THE ABOVE-REFERENCE PROJECT AND TO ACT AS THE AUTHORIZED CORRESPONDENT FOR SAID PROJECT. DONE THIS 28th DAY OF APRIL 2020.
