A RESOLUTION FOR APPLICATION AND ADMINISTRATION OF U.S. DEPARTMENT OF JUSTICE FY2020 PATRICK LEAHY BULLETPROOF VEST PARTNERSHIP PROGRAM FUNDS

WHEREAS, THE U.S. DEPARTMENT OF JUSTICE, OFFICE OF JUSTICE PROGRAMS, BUREAU OF JUSTICE ASSISTANCE IS CURRENTLY SEEKING APPLICATIONS FOR THE FY2020 PATRICK LEAHY BULLETPROOF VEST PARTNERSHIP PROGRAM; AND

WHEREAS, FUNDS AWARDED UNDER THE PROGRAM ARE TO BE UTILIZED TO REIMBURSE COMMUNITIES FOR THE PURCHASE OF BULLETPROOF VESTS TO PROTECT LAW ENFORCEMENT PERSONNEL; AND

WHEREAS, ALL VESTS PURCHASED WITH THESE FUNDS MUST MEET NATIONAL INSTITUTE OF JUSTICE STANDARDS AND MUST BE AMERICAN MADE; AND

WHEREAS, THE MADISON COUNTY FISCAL COURT, KENTUCKY, DESIRES TO MAKE AN APPLICATION FOR THE FY2020 PATRICK LEAHY BULLETPROOF VEST PARTNERSHIP (BVP) PROGRAM; AND

WHEREAS, THE COUNTY OF MADISON, KENTUCKY, WISHES TO AUTHORIZE THE JUDGE EXECUTIVE TO MAKE APPLICATION FOR THE FY2020 PATRICK LEAHY BULLETPROOF VEST PARTNERSHIP PROGRAM, AND IF THE APPLICATION IS SUCCESSFUL, TO ENTER INTO AN AGREEMENT WITH THE OFFICE OF JUSTICE PROGRAMS TO ADMINISTER THIS AWARD, TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY TO FACILITATE AND ADMINISTER THE AWARD, TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THIS AWARD; AND

WHEREAS, THE NUMBER OF COMMUNITIES THAT WILL REQUEST TO PARTICIPATE IN THE FY2020 BULLETPROOF VEST PARTNERSHIP IS UNKNOWN AT THIS TIME THEREFORE THE AMOUNT MADISON COUNTY WILL RECEIVE (IF ANY) WILL NOT BE DETERMINED UNTIL THE TIME OF AWARD; AND

WHEREAS, THERE IS A 50 PERCENT NON-FEDERAL (CASH) LOCAL MATCH REQUIRED WHICH WILL BE PROVIDED BY THE MADISON COUNTY SHERIFF UNLESS AN ECONOMIC HARDSHIP WAIVER IS SUBMITTED TO AND APPROVED BY THE DEPARTMENT OF JUSTICE; AND

NOW, THEREFORE, BE IT RESOLVED THIS 26TH DAY OF MAY 2020, BY MADISON COUNTY, KENTUCKY

THE JUDGE EXECUTIVE IS HEREBY AUTHORIZED TO EXECUTE AND FURNISH ALL REQUIRED DOCUMENTATION, INCLUDING MEMORANDUM OF AGREEMENTS, AS MAY BE REQUIRED FOR THE FURTHERANCE OF THE ABOVE-REFERENCE PROJECT AND TO ACT AS THE AUTHORIZED CORRESPONDENT FOR SAID PROJECT.
