**A RESOLUTION TO RENEW THE HEALTH SERVICES AGREEMENT
BETWEEN MADISON COUNTY, KENTUCKY (HEREINAFTER REFERRED
TO AS "COUNTY") AND SOUTHERN HEALTH PARTNERS, INC, A
DELAWARE CORPORATION (HEREINAFTER REFERRED TO AS "SHP")**

WHEREAS, County and SHP desire to renew the Health Services Agreement between County and SHP; and

WHEREAS, County has partnered with SHP for the past five years to handle the medical care program at the Detention Center; and

WHEREAS, the contract period will be July 1, 2020 through June 30, 2021; and

WHEREAS, for SHP to remain competitive while still retaining their quality, they will need an inflationary adjustment on the contract, effective July 1st in line with the renewal anniversary; and

WHEREAS, the pricing below reflects a 3% annual increase as well as SHP's increased experience, high-quality service and reputation within the industry. The difference in the base rate is \$914.79 more per month.

Contract Period: July 1, 2020 through June 30, 2021	
Base annualized fee:	\$395,762.04 (\$32,980.17 per month)
Per diem greater than 375:	\$1.39

WHEREAS, except as modified above, or as may be further amended or modified by mutual agreement between the parties, all provisions of the contract will remain in full force and effect during the renewal period; and

NOW, THEREFORE, BE IT RESOLVED THAT THE FISCAL COURT DOES HEREBY APPROVE TO ENTER INTO THIS AGREEMENT AND AUTHORIZES THE JUDGE EXECUTIVE TO EXECUTE SAME ON BEHALF OF THE COUNTY.
