**A RESOLUTION FOR APPLICATION AND ADMINISTRATION OF DEPARTMENT
OF HOMELAND SECURITY, FEDERAL EMERGENCY MANAGEMENT AGENCY,
GRANT PROGRAMS DIRECTORATE FEDERAL FISCAL YEAR 2020 ASSISTANCE
TO FIREFIGHTERS GRANT (AFG) FUNDS**

WHEREAS, THE FEDERAL FISCAL YEAR 2020 ASSISTANCE TO FIREFIGHTERS GRANT NOTICE OF FUNDING OPPORTUNITY ALLOWS ELIGIBLE COMMUNITIES TO APPLY FOR AFG FUNDS TO BE USED FOR: (1) OPERATIONS AND SAFETY; (2) VEHICLE ACQUISITION AND; (3) REGIONAL PROJECTS; AND

WHEREAS, THE MADISON COUNTY FISCAL COURT, KENTUCKY, DESIRES TO MAKE AN APPLICATION FOR FEDERAL FISCAL YEAR 2020 AFG FUNDS; AND

WHEREAS, THE COUNTY OF MADISON, KENTUCKY, WISHES TO AUTHORIZE THE JUDGE EXECUTIVE TO MAKE APPLICATION FOR FEDERAL FISCAL YEAR 2020 AFG FUNDS, AND IF THE APPLICATION IS SUCCESSFUL, TO ENTER INTO AN AGREEMENT WITH THE DEPARTMENT OF HOMELAND SECURITY TO ADMINISTER THE FEDERAL FISCAL YEAR 2020 AFG FUNDS AWARD, TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY TO FACILITATE AND ADMINISTER THE AWARD, TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THE AWARD; AND

WHEREAS, THE TOTAL AMOUNT OF AFG FY2020 FUNDING AVAILABLE NATIONWIDE IS 319.5 MILLION DOLLARS AND THE PROJECTED NUMBER OF AWARDS IS 2,000 AND THE AMOUNT MADISON COUNTY WILL RECEIVE (IF ANY) WILL NOT BE DETERMINED UNTIL AFTER THE AWARD DATE OF APRIL 30, 2021; AND

WHEREAS, MADISON COUNTY IS APPLYING FOR A PORTION OF THE AVAILABLE AFG FUNDING IN THE OPERATIONS AND SAFETY CATEGORY TO PURCHASE EQUIPMENT TO BE USED FOR CLEANING PERSONAL PROTECTIVE EQUIPMENT; AND

WHEREAS, THERE IS A 10 PERCENT LOCAL HARD MATCH (CASH) MATCH REQUIRED; AND

NOW, THEREFORE, BE IT RESOLVED THIS 26TH DAY OF JANUARY 2021, BY MADISON COUNTY, KENTUCKY THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE IS HEREBY AUTHORIZED TO EXECUTE AND FURNISH ALL REQUIRED DOCUMENTATION, INCLUDING MEMORANDUM OF AGREEMENTS, AS MAY BE REQUIRED FOR THE FURTHERANCE OF THE ABOVE-REFERENCED PROJECT AND TO ACT AS THE AUTHORIZED CORRESPONDENT FOR SAID PROJECT.

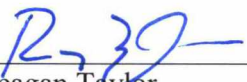
