AND THE CITY OF RICHMOND ACKNOWLEDGING THE DESIRE TO
COLLABORATE ON ECONOMIC DEVELOPMENT PROJECTS
IMPACTING ALL JURISDICTIONS**

WHEREAS, MADISON COUNTY, THE CITY OF BEREAS, AND THE CITY OF RICHMOND ARE COMMITTED TO MAXIMIZING THE ECONOMIC DEVELOPMENT OPPORTUNITIES FOR THE CITIZENS OF MADISON COUNTY; AND

WHEREAS, THE THREE JURISDICTIONS RECOGNIZE THE NEED FOR COLLABORATION TO RECRUIT LARGE EMPLOYERS AND BRING JOBS AND OPPORTUNITIES TO OUR COUNTY; AND

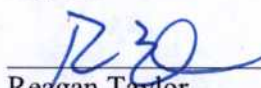

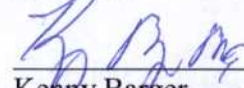
