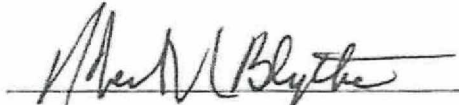
APPOINTMENT TO THE MADISON AIRPORT BOARD, INC.

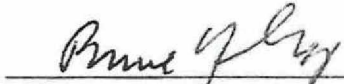
This will be a four-year term set to expire on September 14, 2025.

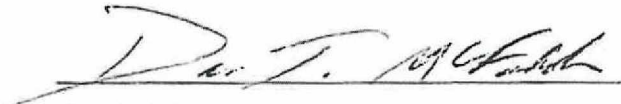
