NOW, THEREFORE, BE IT RESOLVED THIS 9TH DAY OF NOVEMBER 2021, THE MADISON COUNTY FISCAL COURT DOES HEREBY APPROVE THIS RESOLUTION AND AUTHORIZES THE JUDGE EXECUTIVE TO EXECUTE SAME ON BEHALF OF THE COUNTY AS FOLLOWS:

The Madison County Fiscal Court agrees and resolves to apply for HUD Community Development Block Grant funds in the amount of \$1,000,000 for use in a project entitled "God's Outreach Food Distribution Center CDBG," and further authorizes Madison County Judge Executive, Reagan Taylor, to sign all documents necessary to seek the federal financial support that would enable this project to move forward.
