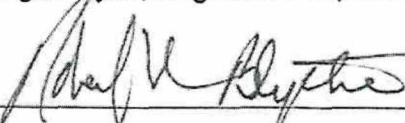
This will be a four-year term set to expire on January 1, 2026.

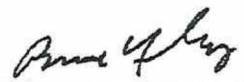

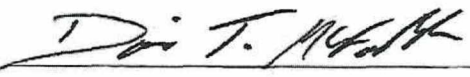

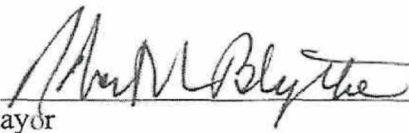
