WHEREAS, the Madison County Fiscal Court shall pay the County Clerk fifteen cents (0.15) for the calculation of a tax bill for each account; and

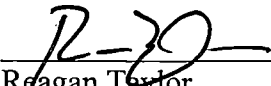
WHEREAS, the total claim to be paid by the Madison County Fiscal Court is \$14,239.50.

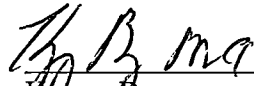
