A RESOLUTION TO APPROVE A MEMORANDUM OF AGREEMENT
BETWEEN MADISON COUNTY FISCAL COURT AND MADISON
COUNTY HEALTH DEPARTMENT (MCHD)

WHEREAS, Madison County Fiscal Court and Madison County Health Department desire to enter into this Memorandum of Agreement to coordinate Safety City programs in collaboration with the Madison County Fire Department and other community partners, in order to take a lead role in the operations of safety education and training programs at the facility; and

WHEREAS, Madison County Fiscal Court agrees to maintain the Safety City property and keep it in good repair and to furnish utilities, insurance, janitorial maintenance services, phone, computer, and internet connectivity for the facility; and

WHEREAS, the Madison County Health Department agrees that MCHD Community Health Education staff will use the office for scheduled classes and other activities as needed; and

WHEREAS, no payments shall be made by either party under the terms of this Agreement; and

WHEREAS, the duration of this Agreement shall be for a period of one (1) year from the date signed or until terminated by a participating party upon thirty (30) days' written notice.

NOW, THEREFORE, BE IT RESOLVED THAT THE FISCAL COURT DOES HEREBY APPROVE TO ENTER INTO THIS AGREEMENT AND AUTHORIZES THE JUDGE EXECUTIVE TO EXECUTE SAME ON BEHALF OF THE COUNTY.

MEMORANDUM OF AGREEMENT

July 1, 2021 to June 30, 2022

The Madison County Health Department wishes to establish an agreement with the Madison County Fiscal Court to coordinate Safety City programs in collaboration with the Madison County Fire Department and other community partners, to take a lead role in the operations of safety education and training programs at the facility. Expansion of safety programs at Safety City will allow it to serve as an expanded learning lab for the identification of risk-taking behaviors and sources of danger and injury prevention and is essential to the operation of the Health Department in fulfilling its core public health functions responsibilities to its clients and the community.

I. Both parties, **Madison County Fiscal Court**, and the **Madison County Health Department**, agree to the following:

- A. Madison County Fiscal Court agrees to maintain the Safety City property and keep it in good repair and to furnish utilities, insurance, janitorial maintenance services, phone, computer and internet connectivity for the facility.
- B. The Madison County Health Department agrees that MCHD Community Health Education staff will use the office for scheduled classes and other activities as needed. Lloyd Jordison, RN will carry out the duties of his position description as the Health Department's Health Education Director and Madison County Safety Coalition Coordinator. In addition, MCHD Community Health Education staff will assist with scheduling of the building for group meetings at Safety City.
- C. The Health Department agrees to the following list of programming at Safety City, which may include but is not limited to:
 - Promote Safety Programming in the community and with local schools.
 - Coordinate local, regional, and state experts in the provision of safety programming/training.
 - Serve as a site for Child Passenger Safety Seat Program training through the Madison County Safety Coalition.
 - Provide various trainings, i.e., Child Passenger Safety Technician, Road Safety Audits, Stop the Bleed, CheckPoints young driver's education, and other traffic safety programs.
 - Serve as a learning lab for college students who are focusing on implementation of safety programs for local schools and community.

D. No payments shall be made by either party under the terms of this agreement.

II. Terms of Agreement

The duration of the Agreement shall be for a period of one (1) year from the date or until terminated by a participating party upon thirty (30) days written notice.

III. Approval

This Memorandum of Agreement shall become effective after approval and execution by both parties.
