**A RESOLUTION FOR APPLICATION AND ADMINISTRATION
OF U.S. DEPARTMENT OF TRANSPORTATION FY2021
RAISE GRANT PROGRAM FUNDS**

WHEREAS, THE U.S. DEPARTMENT OF TRANSPORTATION IS ACCEPTING APPLICATIONS FOR THE FY2021 REBUILDING AMERICAN INFRASTRUCTURE WITH SUSTAINABILITY AND EQUITY (RAISE) TRANSPORTATION DISCRETIONARY GRANT PROGRAM; AND

WHEREAS, FUNDS FOR THE FY2021 RAISE TRANSPORTATION GRANT PROGRAM ARE TO BE AWARDED ON A COMPETITIVE BASIS FOR SURFACE TRANSPORTATION INFRASTRUCTURE PROJECTS THAT WILL HAVE A SIGNIFICANT LOCAL OR REGIONAL IMPACT; AND

WHEREAS, FUNDS AWARDED UNDER THIS PROGRAM MAY BE USED FOR ROADS, BRIDGES, TRANSIT, RAIL, PORTS, OR INTERMODAL TRANSPORTATION; AND

WHEREAS, THE MADISON COUNTY FISCAL COURT, KENTUCKY, DESIRES TO MAKE AN APPLICATION FOR FY2021 DEPARTMENT OF TRANSPORTATION RAISE GRANT PROGRAM FUNDING FOR CONSTRUCTION OF A ROADWAY CONNECTING THE NEW KENTUCKY ROUTE 52 TO MADISON AIRPORT ROAD; AND

WHEREAS, THE COUNTY OF MADISON, KENTUCKY, WISHES TO AUTHORIZE THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE TO MAKE APPLICATION FOR FY2021 DEPARTMENT OF TRANSPORTATION RAISE PROGRAM FUNDING, AND IF THE APPLICATION IS SUCCESSFUL, TO ENTER INTO AN AGREEMENT WITH THE DEPARTMENT OF TRANSPORTATION TO ADMINISTER THIS AWARD, TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY TO FACILITATE AND ADMINISTER THIS AWARD, TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THIS AWARD; AND

WHEREAS, MADISON COUNTY FISCAL COURT IS REQUESTING DEPARTMENT OF TRANSPORTATION RAISE GRANT FUNDS IN AN AMOUNT WHICH WILL BE SPECIFIED IN THE GRANT APPLICATION WHICH IS CURRENTLY BEING PREPARED FOR SUBMITTAL; AND

WHEREAS, A LOCAL MATCH IS NOT REQUIRED AND LOCAL FUNDING IS NOT CONSIDERED IN THE SCORING OF RAISE GRANT APPLICATIONS; AND

NOW, THEREFORE, BE IT RESOLVED THIS 8TH DAY OF JUNE 2021, BY MADISON COUNTY, KENTUCKY THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE IS HEREBY AUTHORIZED TO EXECUTE AND FURNISH ALL REQUIRED DOCUMENTATION, INCLUDING MEMORANDUM OF AGREEMENTS, AS MAY BE REQUIRED FOR THE FURTHERANCE OF THE ABOVE-REFERENCED PROJECT AND TO ACT AS THE AUTHORIZED CORRESPONDENT FOR SAID PROJECT.

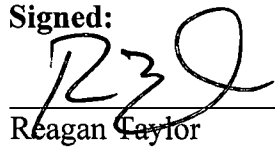
