**A RESOLUTION FOR APPLICATION AND ADMINISTRATION OF FY2021
EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT
(JAG) PROGRAM AWARD**

WHEREAS, THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG) PROGRAM ALLOWS UNITS OF LOCAL GOVERNMENT TO SUPPORT A BROAD RANGE OF CRIMINAL JUSTICE RELATED ACTIVITIES BASED ON THEIR OWN LOCAL NEEDS AND CONDITIONS; AND

WHEREAS, THE MADISON COUNTY FISCAL COURT, KENTUCKY, DESIRES TO MAKE AN APPLICATION FOR THE FY21 JAG PROGRAM AWARD; AND

WHEREAS, THE FY21 JAG AWARD AMOUNT ALLOCATION IS \$11,392.00, WHICH WILL BE SPLIT EQUALLY BETWEEN MADISON COUNTY AND THE CITY OF RICHMOND VIA AN INTERLOCAL AGREEMENT; AND

WHEREAS, THERE IS NO LOCAL MATCH REQUIRED;

NOW, THEREFORE, BE IT RESOLVED THIS 13TH DAY OF JULY 2021, BY MADISON COUNTY, KENTUCKY THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE IS HEREBY AUTHORIZED TO EXECUTE AND FURNISH ALL REQUIRED DOCUMENTATION, INCLUDING MEMORANDUM OF AGREEMENTS, AS MAY BE REQUIRED FOR THE FURTHERANCE OF THE ABOVE-REFERENCED PROJECT AND TO ACT AS THE AUTHORIZED CORRESPONDENT FOR SAID PROJECT.

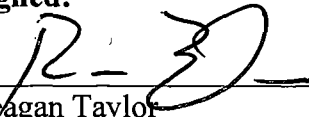

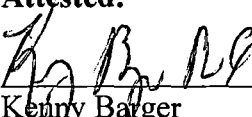
