**A RESOLUTION APPROVING A NOTIFICATION REQUIREMENT FOR FMC
RICHMOND AND MADISON COUNTY EMERGENCY MANAGEMENT AGENCY**

WHEREAS, the Madison County Emergency Management Agency recognizes that, given an emergency disruption of service, the Madison County Emergency Management Agency will be assisting in providing special assistance as available and applicable for the Fresenius Medical Care FMC in Richmond, Kentucky; and

WHEREAS, the Madison County Emergency Management Agency will work to provide priority assistance, as available and applicable, via power restoration, communications, security, supplies, water, fuel, sandbags, and occasionally transport, which is attached hereto this Resolution; and

WHEREAS, the duration of this Agreement shall be for a period of one (1) year from the date signed with automatic renewals every year following, or until terminated by a participating party upon (30) days' written notice;

NOW, THEREFORE, BE IT RESOLVED THAT THE FISCAL COURT DOES HEREBY APPROVE THIS RESOLUTION AND AUTHORIZES THE EMERGENCY MANAGEMENT AGENCY DIRECTOR TO EXECUTE SAME ON BEHALF OF THE COUNTY.

Re: **Annual Notification Requirement – Local Emergency Operations Center**

Dear Sir or Madam:

Recent changes to the Federal Medicare regulations governing the operations of dialysis facilities (42 CFR § 494.62 Condition of Participation: Emergency Preparedness of the Federal Regulations, "Conditions for Coverage for Suppliers of End Stage Renal Disease Services") require Medicare certified dialysis facilities to establish initial and ongoing annual communication with the local Emergency Operations Center (EOC). I would like the opportunity to meet with you to determine how our team at FMC Central Richmond, located at 1036 Center Drive, can work together with your organization during a disaster. We provide service for approximately 63 ESRD patients with incenter hemodialysis; we also provide support services for 18 patients who perform home dialysis.

Our facility has an Emergency Plan and staff is trained and drills performed to prepare for emergency disruption of service. Our facility is equipped with any emergency with Automatic Transfer Switch (ATS) to connect to a mobile generator. We have contracts OR supply arrangements with local water supply companies to provide tanker water, if needed. We also have back up agreements with other nearby clinics to serve our patients if we cannot operate.

Clearly our interest is to be able to continue to provide life sustaining dialysis and support services to our patients. This letter is to advise that in the event our resources are exhausted, we ask to be given priority for assistance with commercial power restoration, assistance with communications, security, supplies, obtaining water or fuel, sandbags and in severe situations with arranging transportation for staff and patients. We also would like to participate in any community-wide drills that are coordinated through your center.
