**A RESOLUTION FOR APPLICATION AND ADMINISTRATION OF
2022 BOW WOW BUDDIES FOUNDATION
SECOND CHANCE GANT**

WHEREAS, THE BOW WOW BUDDIES FOUNDATION IS ACCEPTING APPLICATIONS FOR THE 2022 SECOND CHANCE GRANT PROGRAM; AND

WHEREAS, FUNDS FOR THE 2022 BOW WOW BUDDIES FOUNDATION SECOND CHANCE GRANT PROGRAM ARE TO BE AWARDED ON A COMPETITIVE BASIS FOR MEDICAL EXPENSES FOR AN INJURED CANINE; AND

WHEREAS, THE MADISON COUNTY FISCAL COURT, KENTUCKY, DESIRES TO MAKE AN APPLICATION FOR THE 2022 BOW WOW BUDDIES FOUNDATION GRANT PROGRAM FUNDS TO PAY FOR REQUIRED CANINE SURGERIES IN MADISON COUNTY; AND

WHEREAS, THE COUNTY OF MADISON, KENTUCKY, WISHES TO AUTHORIZE THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE TO MAKE APPLICATION FOR THESE 2022 BOW WOW BUDDIES SECOND CHANCE GRANT PROGRAM FUNDS, AND IF THE APPLICATION IS SUCCESSFUL, TO ENTER INTO AN AGREEMENT WITH THE BOW WOW BUDDIES FOUNDATION TO ADMINISTER THIS AWARD, TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY TO FACILITATE AND ADMINISTER THIS AWARD, TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THIS AWARD; AND

WHEREAS, THE BOW WOW BUDDIES FOUNDATION WILL AWARD UP TO \$2,500 TOWARDS VETERINARY EXPENSES FOR ONE CANINE PER YEAR TO APPLICANTS ON A COMPETITIVE BASIS; AND

WHEREAS, MADISON COUNTY FISCAL COURT IS REQUESTING KENTUCKY BOW WOW BUDDIES FOUNDATION GRANT FUNDS IN AN AMOUNT DEPENDANT ON FUTURE VETERINARY MEDICAL EXPENSES;
