AGENCY (EMA)/CHEMICAL STOCKPILE EMERGENCY PREPAREDNESS PROGRAM
(CSEPP) DIRECTOR**

WHEREAS, the Madison County EMA/CSEPP Director position is vacant; and

WHEREAS, KRS 39B.020 states the county judge executive shall appoint a local emergency management director who meets all qualifications criteria pursuant to KRS Chapters 39A to 39F, and shall immediately notify the director of the Division of Emergency Management of the appointment; and

WHEREAS, the Madison County Fiscal Court desires to appoint Tim Gray, Fire Chief, as the Interim Madison County EMA/CSEPP Director; and

WHEREAS, Tim Gray meets the qualifications criteria for this position; and

WHEREAS, the Madison County Fiscal Court agrees to pay Tim Gray \$200.00 per week for these additional responsibilities during his interim term to retroactively go into effect December 7, 2022;

**NOW, THEREFORE, BE IT RESOLVED THAT THE FISCAL COURT DOES HEREBY
APPROVE THIS APPOINTMENT TO RETROACTIVELY GO INTO EFFECT DECEMBER 6,
2022 AND AUTHORIZES THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE TO EXECUTE
SAME ON BEHALF OF THE COUNTY.**
