**A RESOLUTION FOR APPLICATION AND ADMINISTRATION OF THE DEPARTMENT OF
HOMELAND SECURITY, FEDERAL EMERGENCY MANAGEMENT AGENCY, GRANT
PROGRAMS DIRECTORATE FEDERAL FISCAL YEAR 2022 STAFFING FOR ADEQUATE
FIRE AND EMERGENCY RESPONSE (SAFER) GRANT PROGRAM**

WHEREAS, THE FEDERAL FISCAL YEAR 2022 STAFFING FOR ADEQUATE FIRE AND EMERGENCY RESPONSE GRANT FUNDING OPPORTUNITY ALLOWS ELIGIBLE COMMUNITIES TO APPLY FOR SAFER FUNDS TO ASSIST LOCAL FIRE DEPARTMENTS WITH STAFFING AND DEPLOYMENT CAPABILITIES; AND

WHEREAS, THE MADISON COUNTY FISCAL COURT, KENTUCKY, DESIRES TO MAKE AN APPLICATION FOR FEDERAL FISCAL YEAR 2022 SAFER FUNDS; AND

WHEREAS, THE COUNTY OF MADISON, KENTUCKY, WISHES TO AUTHORIZE THE JUDGE EXECUTIVE TO MAKE APPLICATION FOR FEDERAL FISCAL YEAR 2022 SAFER FUNDS, AND IF THE APPLICATION IS SUCCESSFUL, TO ENTER INTO AN AGREEMENT WITH THE DEPARTMENT OF HOMELAND SECURITY TO ADMINISTER THE AWARD, TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY TO FACILITATE AND ADMINISTER THE AWARD, TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THE AWARD; AND

WHEREAS, THE AMOUNT MADISON COUNTY WILL RECEIVE (IF ANY) WILL NOT BE DETERMINED UNTIL THE AWARD DATE IN 2023; AND

WHEREAS, MADISON COUNTY IS APPLYING FOR A PORTION OF THE AVAILABLE SAFER FUNDING; AND

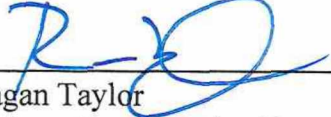
WHEREAS, A LOCAL COST MATCH IS NOT REQUIRED;

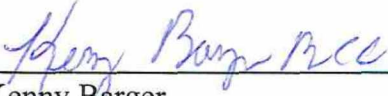
