**A RESOLUTION FOR APPLICATION AND ADMINISTRATION OF
FISCAL YEAR 2023 U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES
RURAL COMMUNITIES OPIOID RESPONSE PROGRAM GRANT**

WHEREAS, THE U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES IS ACCEPTING APPLICATIONS FOR THE FY 2023 RURAL COMMUNITIES OPIOID RESPONSE PROGRAM GRANT; AND

WHEREAS, FUNDS FOR THE 2023 U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES RURAL COMMUNITIES OPIOID RESPONSE PROGRAM GRANT ARE TO BE AWARDED ON A COMPETITIVE BASIS FOR REDUCING THE MORBIDITY AND MORTALITY OF SUBSTANCE USE DISORDER IN HIGH-RISK RURAL COMMUNITIES; AND

WHEREAS, THE MADISON COUNTY FISCAL COURT, KENTUCKY, DESIRES TO MAKE AN APPLICATION FOR THE 2023 RURAL COMMUNITIES OPIOID RESPONSE PROGRAM GRANT FUNDS TO PAY FOR SUBSTANCE ABUSE DISORDER MITIGATION MEASURES IN MADISON COUNTY; AND

WHEREAS, THE COUNTY OF MADISON, KENTUCKY, WISHES TO AUTHORIZE THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE TO MAKE APPLICATION FOR THESE 2023 U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES RURAL COMMUNITIES OPIOID RESPONSE PROGRAM GRANT, AND IF THE APPLICATION IS SUCCESSFUL, TO ENTER INTO AN AGREEMENT WITH THE U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES TO ADMINISTER THIS AWARD, TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY TO FACILITATE AND ADMINISTER THIS AWARD, TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THIS AWARD; AND

WHEREAS, THE U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES WILL AWARD UP TO \$300,000 TOWARDS IMMEDIATE RESPONSES TO THE OPIOID CRISIS IN RURAL AREAS TO APPLICANTS ON A COMPETITIVE BASIS; AND

WHEREAS, A LOCAL MATCH IS NOT REQUIRED; AND

WHEREAS, MADISON COUNTY FISCAL COURT IS REQUESTING U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES GRANT FUNDS IN AN AMOUNT DEPENDENT ON FUTURE DETERMINATION;

NOW, THEREFORE, BE IT RESOLVED THIS 13TH DAY OF DECEMBER 2022, BY MADISON COUNTY, KENTUCKY THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE IS HEREBY AUTHORIZED TO EXECUTE AND FURNISH ALL REQUIRED DOCUMENTATION, INCLUDING MEMORANDUM OF AGREEMENTS, AS MAY BE REQUIRED FOR THE FURTHERANCE OF THE ABOVE-REFERENCED PROJECT AND TO ACT AS THE AUTHORIZED CORRESPONDENT FOR SAID PROJECT.
