**WHEREAS**, the Madison County Fiscal Court has found Kimberly S. Campbell as fit for the position as board member of the Valley View Ferry Board;

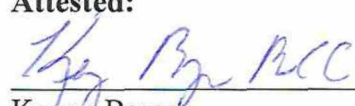

## **BOARD APPOINTMENT**

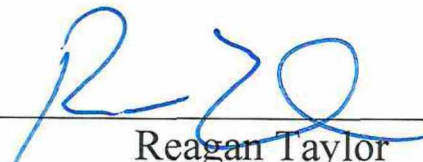
Madison County Fiscal Court ORDER APPOINTING
