**A RESOLUTION APPROVING THE NEWSPAPER OF RECORD
FOR REQUIRED ADVERTISING**

WHEREAS, pursuant to KRS 424.145, alternative Internet and newspaper publication procedures for local governments are permissible; and

WHEREAS, beginning January 1, 2024, in lieu of newspaper publication, Madison County Fiscal Court began posting any and all public notices and public hearings, as well as any and all bids, Request for Proposals (RFP), Request for Quotes (RFQ), or specifications on their website at www.madisoncountky.gov/public-notices. All items are available for viewing at 135 W. Irvine St., Suite 300, Richmond, KY by calling 859-624-4700.

WHEREAS, in conjunction with an alternative Internet posting, Madison County Fiscal Court published a newspaper advertisement in the Richmond Register and the Berea Citizen newspapers providing citizens public notice of this change; and

WHEREAS, in addition to Internet postings, some advertisements are still required to be published in the newspaper having the largest bona fide paid circulation as outlined in KRS 424.120; and

WHEREAS, Richmond Register mistakenly sent incorrect data when they filed their published statement of ownership on October 1, 2023; and

WHEREAS, Richmond Register and Berea Citizen acknowledge the error, which means Richmond Register is the largest bona fide paid circulation for the publication area for required newspaper advertisements to be published;

NOW, THEREFORE, BE IT RESOLVED THAT THE FISCAL COURT DOES HEREBY APPROVE THIS RESOLUTION AND AUTHORIZES THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE TO EXECUTE THE SAME ON BEHALF OF THE COUNTY.

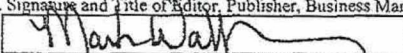
