**A RESOLUTION FOR APPLICATION AND ADMINISTRATION OF
UNITED SPAY ALLIANCE COMMUNITY CATS GRANTS PROGRAM FUNDS**

WHEREAS, United Spay Alliance is currently accepting applications for their Community Cats Grants Program to support spay and neuter programs for community cats; and

WHEREAS, funds for the Community Cats Grants program are to be awarded on a competitive basis and are targeted toward trap-neuter-return (TNR) groups, rescue organizations, and low-cost spay/neuter providers; and

WHEREAS, the Madison County Fiscal Court, Kentucky, desires to make an application for the United Spay Alliance Community Cats Grants Program funds to spay and neuter community cats in Madison County; and

WHEREAS, the United Spay Alliance Community Cats Grants Program funds application request will be in the amount of \$2,000.00; and

WHEREAS, grantees must create and implement a brand-new fundraiser to receive a matching grant of up to \$2,000.00 from United Spay Alliance;

NOW, THEREFORE, BE IT RESOLVED THIS 12TH DAY OF MARCH 2024 BY MADISON COUNTY, KENTUCKY, THAT THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE IS HEREBY AUTHORIZED TO MAKE APPLICATION FOR THESE FUNDS, AND IF THE APPLICATION IS SUCCESSFUL, TO ENTER INTO AGREEMENTS WITH UNITED SPAY ALLIANCE, TO ADMINISTER THESE GRANT FUNDS, TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY TO FACILITATE AND ADMINISTER THE AWARD, AND TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THE ABOVE-REFERENCED PROJECT.
