**A RESOLUTION APPROVING EMERGENCY FUNDING FOR THE DOYLESVILLE  
ROAD BRIDGE REPLACEMENT IN THE AMOUNT OF \$100,000.00**

**WHEREAS**, it would be to the benefit of the traveling public to replace a bridge on Doylesville Road (CR 1044), and the Commonwealth of Kentucky, Transportation Cabinet, Department of Rural and Municipal Aid, has agreed to provide emergency funding to Madison County Fiscal Court (the "County") for Project #17958 (the "Project"); and

**WHEREAS**, the Transportation Cabinet shall be responsible for providing and agrees to reimburse the County up to the amount of eighty percent (80%) of the actual Project cost. The County shall be responsible for twenty percent (20%) of the cost as well as any amount over \$100,000; and

**WHEREAS**, fifty percent (50%) of that amount, \$50,000 will be processed immediately and sent via check. Once the project is completed, the remaining balance of \$50,000 will then be processed and sent via a second check. However, the final payment will be adjusted as necessary if the total Project cost is less than the amount from which the approval was calculated;

**NOW, THEREFORE, BE IT RESOLVED THAT THE MADISON COUNTY FISCAL COURT DOES HEREBY APPROVE THIS RESOLUTION AND AUTHORIZES THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE TO EXECUTE THE SAME ON BEHALF OF THE COUNTY.**

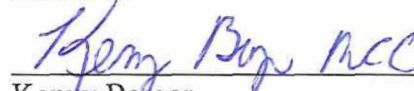

Dear Judge Taylor,

On April 12, 2024, Project #17958 was authorized to provide the county of Madison funding for a bridge repair on Doylesville Road (CR 1044) located 0.173 miles north of Weddles Mill Road (CR 1068), extending northwest to the ending mile-point 0.195. The county of Madison was approved for \$100,000. Fifty percent (50%) of that amount, \$50,000 will be processed, and sent to you via check.

We ask that the county complete this project by April 12, 2025. Within 60 days after the completion date, please submit form TC 20-38 along with copies of all invoices, photographs of the completed project, and other supporting documents to [RuralandMunicipalAid@ky.gov](mailto:RuralandMunicipalAid@ky.gov) or to:

The remaining balance of \$50,000 will then be processed and sent to you via a second check. However, the final payment will be adjusted as necessary if the total project cost is less than the amount from which the approval was calculated. The county is responsible for 20% of the project cost as well as any amount over \$100,000.
