**A RESOLUTION TO ADOPT 2024-2025 HEALTH INSURANCE  
RENEWAL RATES AND CARRIERS**

**WHEREAS**, the Madison County Fiscal Court has established a voluntary insurance plan to benefit full-time employees; and

**WHEREAS**, the insurance rates are updated annually; and

**WHEREAS**, it is the role of the Fiscal Court to determine the rate for the employer portion of health and life insurance and to select vendors for optional policies to offer said employees;

**NOW, THEREFORE, BE IT RESOLVED THAT THE FISCAL COURT DOES HEREBY APPROVE TO ADOPT 2024-2025 HEALTH INSURANCE RENEWAL RATES AND CARRIERS AS FOLLOWS:**

1. Health Insurance – United Healthcare through United Medical Resources (UMR), at the rate of \$700 per Fiscal Court employee per month.
2. Basic Life/AD&D – OneAmerica not to exceed \$5.25 per Fiscal Court employee per month.
3. Benefit Marketing Solutions – Flexible Spending Account
4. Dental – Delta Dental
5. Vision – Guardian
6. Voluntary Life – OneAmerica
7. Short Term Disability – OneAmerica
8. Hospital Indemnity, Critical Illness, and Accident Policies – Voya
9. Primary Care Option – Alternative Health Solutions, LLC (BluMine Clinic)

**BE IT FURTHER RESOLVED THAT THE FISCAL COURT DOES HEREBY APPROVE THIS RESOLUTION AND AUTHORIZES THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE TO EXECUTE THE SAME ON BEHALF OF THE COUNTY.**

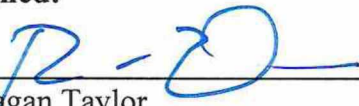
