**A JOINT RESOLUTION OF MADISON COUNTY, THE CITY OF BEREA,
AND THE CITY OF RICHMOND ACKNOWLEDGING THE DESIRE TO
COLLABORATE ON POST-CSEPP PROJECTS IMPACTING ALL JURISDICTIONS**

WHEREAS, MADISON COUNTY, THE CITY OF BEREA, AND THE CITY OF RICHMOND ARE COMMITTED TO MAXIMIZING THE PUBLIC SAFETY AND EMERGENCY RESPONSE FOR THE CITIZENS OF MADISON COUNTY WITHOUT FEDERAL CSEPP FUNDING; AND

WHEREAS, THE THREE JURISDICTIONS RECOGNIZE THE NEED FOR COLLABORATION TO MAINTAIN THE SERVICES CURRENTLY PROVIDED BY CSEPP FOR OUR COUNTY; AND

WHEREAS, THE THREE JURISDICTIONS UNDERSTAND THE NEED TO PREPARE FOR THE LOSS OF FEDERAL CSEPP FUNDING THAT HAS PROVIDED TOOLS AND RESOURCES TO SUPPORT OUR COMMUNITY FOR THE PAST 30 YEARS; AND

WHEREAS, EACH JURISDICTION SHALL APPOINT TWO MEMBERS TO A POST-CSEPP TRANSITION TASK FORCE TO COLLABORATE AND IDENTIFY INNOVATIVE STRATEGIES, FUNDING AND ACTIONABLE RECOMMENDATIONS FOR OUR LEGISLATIVE BODIES.

NOW, THEREFORE, BE IT RESOLVED THIS 12TH DAY OF SEPTEMBER, 2023, BY MADISON COUNTY, KENTUCKY THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE IS HEREBY AUTHORIZED TO REPRESENT THE COUNTY IN JOINT POST-CSEPP TRANSITION TASK FORCE.
