**A RESOLUTION FOR THE MADISON COUNTY FISCAL COURT TO
APPROVE A BID AWARD FOR CYBER SECURITY TOOLS AND SERVICES
TO THE MADISON COUNTY, KY NETWORKS**

WHEREAS, the Madison County Fiscal Court is required to approve of all bids for projects in accordance with the Administrative Code; and

WHEREAS, the bids were needed to provide cyber security tools and services to the Madison County, KY networks with 24/7 monitoring, monthly reporting; and

WHEREAS, the bid notice was properly posted, and one bid was received, opened, and reviewed; and

WHEREAS, the Madison County Chief Information Officer recommends awarding the bid for cyber security tools and services for the Madison County, KY networks to 13 Layers, LLC; and

WHEREAS, the Information Technology Department has budgeted funds for these expenses, and the submitted pricing will fall in line with budgeted funds; and

WHEREAS, pricing is for a term of three years with the option to extend the contract for two years with pricing negotiation in year four. The term of the contract is to retroactively begin July 1, 2024:

ThreatShield t-intelligence - \$40,000.00 year one, \$50,200.00 years two and three.

ThreatShield t-audit - \$5,000.00 per year.

Enhanced Detection and Response at \$120 per instance, per year.

Remote & Patch Management at \$120 per instance, per year.

Multi Factor Authentication not to exceed \$45 per user, per year.

Cyber Security Training and Awareness \$0.00 per user, per year up to 400 users.

Emergency Service \$350 per hour

Standard Services \$225.00 per hour

NOW, THEREFORE, BE IT RESOLVED THAT THE FISCAL COURT DOES HEREBY APPROVE THIS RESOLUTION AND AUTHORIZES THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE TO EXECUTE THE SAME ON BEHALF OF THE COUNTY.
