**A RESOLUTION FOR APPLICATION AND ADMINISTRATION OF CALENDAR
YEAR 2025 KENTUCKY ENERGY AND ENVIRONMENT CABINET DIVISION OF
WASTE MANAGEMENT LITTER ABATEMENT GRANT FUNDS**

WHEREAS, the Kentucky Energy and Environment Cabinet Division of Waste Management calendar year 2025 Litter Abatement Grant allows units of local government to apply for litter abatement grant funds to be used for: (1) Direct expenses as defined in 401 KAR 49:080 Section 3 incurred during calendar year 2025 associated with anti-litter control programs, (2) For litter cleanup on public roads as provided in KRS 224.43-505, (3) to meet the requirements established in KRS 224.43-345; and

WHEREAS, the Madison County Fiscal Court, Kentucky, desires to make an application for calendar year 2025 Litter Abatement Grant funds; and

WHEREAS, the amount of funding available per county will be calculated in accordance with statutory requirements, and the amount of grant funding each county is eligible to receive will not be determined until after November 1, 2024, when all applications are received by the Division of Waste Management; and

WHEREAS, there is no local match required;

NOW, THEREFORE, BE IT RESOLVED THIS 13TH DAY OF AUGUST 2024, BY MADISON COUNTY, KENTUCKY, THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE IS HEREBY AUTHORIZED TO MAKE APPLICATION FOR THESE FUNDS, AND IF THE APPLICATION IS SUCCESSFUL, TO ENTER INTO AN AGREEMENT WITH THE KENTUCKY DIVISION OF WASTE MANAGEMENT, TO ADMINISTER THESE GRANT FUNDS, TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY TO FACILITATE AND ADMINISTER THE AWARD, AND TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THE ABOVE-REFERENCED PROJECT.

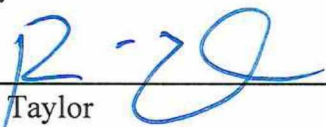

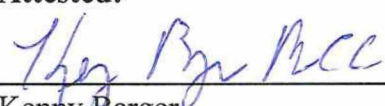
