**A RESOLUTION FOR THE MADISON COUNTY FISCAL COURT TO
APPROVE A BID AWARD FOR KENTUCKY COUNTIES GOVERNMENT CLOUD
(KCGC) MANAGED SERVICES PROVIDER AND MANAGED SECURITY SERVICES
PROVIDER TO PROVIDE CYBER SECURITY TOOLS AND SERVICES**

WHEREAS, the Madison County Fiscal Court is required to approve of all bids for projects in accordance with the Administrative Code; and

WHEREAS, the bids were needed to provide cyber security tools and services to the Madison County, Kentucky KCGC networks and provide customers with 24/7 monitoring, monthly reporting; and

WHEREAS, the bid notice was properly posted, and one bid was received, opened, and reviewed; and

WHEREAS, the Madison County Chief Information Officer recommends awarding the bid for cyber security tools and services for the Madison County, Kentucky KCGC networks and customers to 13 Layers, LLC; and

WHEREAS, the Information Technology Department has realized revenue for these expenses as part of the KCGC Project, and the submitted pricing will fall in line with revenue models; and

WHEREAS, pricing is for a term of three years with the option to extend the contract for two years with pricing negotiation in year four. The term of the contract is to retroactively begin July 1, 2024:
