**A RESOLUTION FOR THE MADISON COUNTY FISCAL COURT TO
APPROVE A BID AWARD FOR KENTUCKY COUNTIES GOVERNMENT CLOUD
(KCGC) END USER EQUIPMENT & LICENSES – SCG/JC**

WHEREAS, the Madison County Fiscal Court is required to approve of all bids for projects in accordance with the Administrative Code; and

WHEREAS, the bids were needed to purchase End User Equipment and Licenses for use in the Madison County, Kentucky KCGC project; and

WHEREAS, the bid notice was properly posted, and two bids were received, opened, and reviewed, CDW-G total package bid was \$171,324.60 and 13 Layers, LLC total package bid was \$175,020.30; and

WHEREAS, Madison County reserved the right in the bid to award the bid either by a full package or by line item, whichever was in the best interest of Madison County; and

WHEREAS, based on the pricing the Madison County Chief Information Officer recommends in the best interest of Madison County to award the bid as follows, all physical equipment in the bid to CDW-G and all Software Licenses in the bid to 13 Layers, LLC, as listed below;

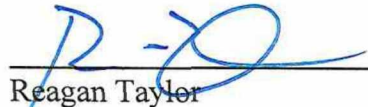

CDW-G (marked with a *) will be awarded \$116,588.20 in equipment, and 13 Layers, LLC (marked with a @) will be awarded \$46,110.00 in software licenses. By awarding in this manner Madison County realized a cost savings of \$8,626.40 compared to the total lowest bid package amount.

NOW, THEREFORE, BE IT RESOLVED THAT THE FISCAL COURT DOES HEREBY APPROVE THIS RESOLUTION AND AUTHORIZES THE JUDGE EXECUTIVE AND/OR HIS DESIGNEE TO NEGOTIATE AND EXECUTE CONTRACTS ON BEHALF OF THE COUNTY.
