**A RESOLUTION FOR THE MADISON COUNTY FISCAL COURT TO
APPROVE A BID AWARD FOR KENTUCKY COUNTIES GOVERNMENT CLOUD
(KCGC) END USER EQUIPMENT & LICENSES – SCG**

WHEREAS, the Madison County Fiscal Court is required to approve all bids for projects in accordance with the Administrative Code; and

WHEREAS, the bids were needed to purchase End User Equipment and Licenses for use in the Madison County, Kentucky KCGC project; and

WHEREAS, the bid notice was properly posted, and two bids were received, opened, and reviewed, 13 Layers, LLC total package bid was \$135,135.00 and CDW Government total package bid was \$137,923.10; and

WHEREAS, Madison County reserved the right in the bid to award the bid either by a full package or by line item, whichever was in the best interest of Madison County; and

WHEREAS, based on the pricing the Madison County Chief Information Officer recommends in the best interest of Madison County to award the bid as listed below;

CDW Government (marked with a *) will be awarded \$33,572.30, and 13 Layers, LLC (marked with a @) will be awarded \$93,510.00. By awarding in this manner Madison County realized a cost savings of \$8,052.70 compared to the total lowest bid package amount.

NOW, THEREFORE, BE IT RESOLVED THAT THE FISCAL COURT DOES HEREBY APPROVE THIS RESOLUTION AND AUTHORIZES THE JUDGE/EXECUTIVE AND/OR HIS DESIGNEE TO NEGOTIATE AND EXECUTE CONTRACTS ON BEHALF OF THE COUNTY.

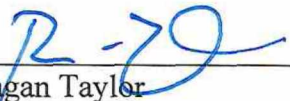

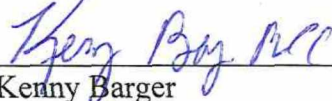
