**A RESOLUTION APPROVING A MEMORANDUM OF AGREEMENT
(MOA) BETWEEN THE COMMONWEALTH OF KENTUCKY, ENERGY AND
ENVIRONMENT CABINET, DIVISION OF WASTE MANAGEMENT AND THE
MADISON COUNTY HOST COMMUNITY LIAISON FOR BLUE GRASS ARMY DEPOT.
THIS RESOLUTION SUPERSEDES RESOLUTION 2023-140.**

WHEREAS, pursuant to KRS 224.50-130(8)(b), this MOA is entered into, by and between the Commonwealth of Kentucky, Energy and Environment Cabinet, Division of Waste Management ("the Commonwealth") and the Madison County Host Community Liaison ("the Contractor") to establish an agreement for a single point of contact for community relations, emergency planning, and community oversight of the construction, operation, closure, and emergency response of the facility; and

WHEREAS, the Madison County Emergency Management Agency (EMA)/CSEP Program work closely with the Blue Grass Army Depot (BGAD) to gather information pertinent to the demilitarization of the chemical weapons at BGAD; and

WHEREAS, the Commonwealth shall reimburse the Contractor for services and activities related to the Bluegrass Army and Chemical Agent Disposal Facility as outlined in the attached MOA; and

WHEREAS, Craig Williams has proven his capability in serving as the BGAD Liaison and is willing to continue serving in this capacity; and

WHEREAS, this MOA is only valid while the Program is being funded by the Commonwealth;

NOW, THEREFORE, BE IT RESOLVED THAT THE FISCAL COURT DOES HEREBY APPROVE THIS RESOLUTION AND AUTHORIZES THE JUDGE/EXECUTIVE AND/OR HIS DESIGNEE TO EXECUTE THE SAME ON BEHALF OF THE COUNTY.
