**A RESOLUTION OF THE MADISON COUNTY FISCAL COURT APPROVING
AN UPDATED MADISON COUNTY EMERGENCY OPERATIONS PLAN
THIS RESOLUTION SUPERSEDES RESOLUTION 2021-13.**

WHEREAS, KRS 39B.010(1), KRS 39B.030(3), KRS 39C.050(3), and applicable Kentucky Administrative Regulations require the development and maintenance of a local emergency operations plan which sets forth the local government organizational structure, policies, procedures, and guidelines for the management and coordination of all disaster and emergency response in Madison County and its cities; and

WHEREAS, KRS 39B.030(3), KRS 39B.060(2), KRS 39C.050(3), applicable Kentucky Administrative Regulations, and planning guidance issued by the Kentucky Division of Emergency Management require the local emergency operations plan to be officially approved and adopted by a signed order of the County Judge/Executive; and

WHEREAS, the Madison County Emergency Management Agency (EMA) director has submitted the Madison County Emergency Operations Plan to the County Judge/Executive for official approval and adoption in accordance with the aforementioned laws, administrative regulations, and planning guidance;

NOW, THEREFORE, BE IT RESOLVED THAT THE MADISON COUNTY FISCAL COURT DOES HEREBY APPROVE THIS RESOLUTION TO SUPERSEDE RESOLUTION 2021-13 AND AUTHORIZES THE JUDGE/EXECUTIVE AND/OR HIS DESIGNEE TO EXECUTE THE SAME ON BEHALF OF THE COUNTY.
