**A RESOLUTION FOR APPLICATION AND ADMINISTRATION OF
2026-2027 KENTUCKY 911 SERVICES BOARD GRANTS**

WHEREAS, the Kentucky 911 Services Board allows units of local government to apply for grant funding to be used to provide upgrades to 911 services; and

WHEREAS, the Madison County Fiscal Court, Kentucky, desires to make applications for these 2026-2027 Kentucky 911 Services Grant Funds for enhancements to facility and technology equipment; and

WHEREAS, these grant funds must be expended during the grant period of July 1, 2026 to June 30, 2027; and

WHEREAS, the Madison County Fiscal Court is requesting Kentucky 911 Services Grant Funds in an amount which will be specified in the grant applications currently being prepared for submittal; and

WHEREAS, there is a ten percent (10%) local match required, which can be in-kind and/or cash;

NOW, THEREFORE, BE IT RESOLVED THIS 24TH DAY OF FEBRUARY 2026, BY MADISON COUNTY, KENTUCKY THAT THE JUDGE/EXECUTIVE AND/OR HIS DESIGNEE IS HEREBY AUTHORIZED TO MAKE APPLICATIONS FOR THESE FUNDS, AND IF THE APPLICATIONS ARE SUCCESSFUL, TO ENTER INTO AGREEMENTS WITH THE KENTUCKY 911 SERVICES BOARD, TO ADMINISTER THESE GRANT FUNDS, TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY TO FACILITATE AND ADMINISTER THE AWARD, AND TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THE ABOVE-REFERENCED PROJECT.
