**A RESOLUTION FOR APPLICATION AND ADMINISTRATION OF
2025-2026 KACo INSURANCE GRANT PROGRAM FUNDS**

WHEREAS, members of the KACo Workers Compensation Fund or the KACo All Lines Fund have the opportunity to apply for grants for future purchases intended to reduce losses/claims covered by either fund, including equipment, training programs, consulting services, and property improvements that reduce the risk of personal injury; and

WHEREAS, the 2025-2026 KACo Insurance Grant Program funds are limited to a maximum reimbursement of \$10,000.00; and

WHEREAS, the Madison County Fiscal Court, Kentucky, desires to make an application for 2025-2026 KACo Insurance Grants Program funds to address any number of the following categories: vehicle accidents, lifting injury incidents, jail operations, personal safety, and cybersecurity improvements; and

WHEREAS, the 2025-2026 KACo Insurance Grant Program is a competitive program, and the amount of grant funding Madison County will receive (if any) will not be known until the grant awards are made by KACo; and

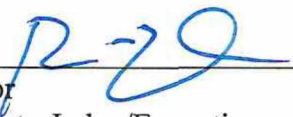
WHEREAS, the Madison County Fiscal Court will be required to contribute a 20 percent (20%) match for any grant awarded for reimbursement of future expenses only;

NOW, THEREFORE, BE IT RESOLVED THIS 26TH DAY OF AUGUST 2025, BY MADISON COUNTY, KENTUCKY, THE JUDGE/EXECUTIVE AND/OR HIS DESIGNEE IS HEREBY AUTHORIZED TO MAKE APPLICATION FOR THESE GRANT FUNDS, AND IF THE APPLICATION IS SUCCESSFUL, TO ENTER INTO AN AGREEMENT WITH KACo, TO ADMINISTER THESE GRANT FUNDS, TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY TO FACILITATE AND ADMINISTER THE AWARD, AND TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THE ABOVE-REFERENCED PROJECT.

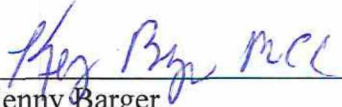
