**A RESOLUTION OF THE MADISON COUNTY FISCAL COURT APPROVING THE
MADISON COUNTY ROAD DEPARTMENT FY 2025-2026 ANNUAL BID AWARDS**

WHEREAS, the Madison County Fiscal Court is required to approve all bids in accordance with the Administrative Code; and
