**A RESOLUTION OF THE FISCAL COURT APPROVING APPLICATION AND
ADMINISTRATION OF THE 2026 KENTUCKY DEPARTMENT OF AGRICULTURE
ANIMAL CONTROL ADVISORY BOARD SPAY AND NEUTER GRANT FUNDS**

WHEREAS, the Kentucky Animal Control Advisory Board (KACAB) is accepting applications for the 2025 Spay and Neuter Grant Program, which will be awarded on a competitive basis; and

WHEREAS, the Madison County Fiscal Court, Kentucky, desires to make an application in the amount of \$1,266.00 for the 2026 KACAB Grant Program funds to spay and neuter companion animals in Madison County; and

WHEREAS, local funding is considered in the scoring of these grant applications, but a local match is not required;

NOW, THEREFORE, BE IT RESOLVED THIS 9TH DAY OF JUNE 2026, BY MADISON COUNTY, KENTUCKY, THE JUDGE/EXECUTIVE AND/OR HIS DESIGNEE IS HEREBY AUTHORIZED TO MAKE APPLICATION FOR THE 2026 KACAB SPAY AND NEUTER COMPANION GRANT PROGRAM FUNDS, AND IF THE APPLICATION IS SUCCESSFUL, TO ENTER INTO AN AGREEMENT WITH THE KACAB TO ADMINISTER THIS AWARD, TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY TO FACILITATE AND ADMINISTER THIS AWARD, AND TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THE ABOVE-REFERENCED PROJECT.
