**A RESOLUTION FOR APPLICATION AND ADMINISTRATION OF  
2026-2027 KACo INSURANCE GRANT PROGRAM FUNDS**

**WHEREAS**, members of the KACo Workers Compensation Fund and KACo All Lines Fund have the opportunity to apply for grants for future purchases intended to help members invest in products, services, and improvements that reduce risk and prevent losses associated with KACO's insurance programs; and

**WHEREAS**, the 2026-2027 KACo Insurance Grant Program funds are limited to a maximum reimbursement of \$10,000.00 for fiscal courts or political subdivisions and \$7,500.00 for jails; and

**WHEREAS**, the Madison County Fiscal Court, Kentucky, desires to make an application for 2026-2027 KACo Insurance Grants Program funds to address any number of the following categories: vehicle accidents, lifting and handling injuries, slip, trip, and fall incidents, property damage, legal liability, and personnel safety; and

**WHEREAS**, the 2026-2027 KACo Insurance Grant Program is a competitive program, and the amount of grant funding Madison County will receive (if any) will not be known until the grant awards are made by KACo; and

**WHEREAS**, the Madison County Fiscal Court will be required to contribute a 20 percent (20%) match for any grant awarded for reimbursement of future expenses only;

**NOW, THEREFORE, BE IT RESOLVED THIS 25<sup>TH</sup> DAY OF AUGUST 2026, BY MADISON COUNTY, KENTUCKY, THE JUDGE/EXECUTIVE AND/OR HIS DESIGNEE IS HEREBY AUTHORIZED TO MAKE APPLICATION FOR THESE GRANT FUNDS, AND IF THE APPLICATION IS SUCCESSFUL, TO ENTER INTO AN AGREEMENT WITH KACo, TO ADMINISTER THESE GRANT FUNDS, TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY TO FACILITATE AND ADMINISTER THE AWARD, AND TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THE ABOVE-REFERENCED PROJECT.**
