A RESOLUTION OF THE MADISON COUNTY FISCAL COURT AUTHORIZING THE FILING OF A KENTUCKY HOUSE BILL ("HB") 900 PROJECT GRANT APPLICATION FOR UP TO \$100,000.00 IN HB 900 FUNDS WITH THE DEPARTMENT FOR LOCAL GOVERNMENT ("DLG") FOR FISCAL YEAR 2026-2027; AUTHORIZING AND DIRECTING THE MADISON COUNTY JUDGE/EXECUTIVE TO EXECUTE ANY DOCUMENTS WHICH ARE DEEMED NECESSARY BY DLG TO CARRY OUT THIS PROJECT; AND AUTHORIZING THE JUDGE/EXECUTIVE TO ACT AS THE AUTHORIZED CORRESPONDENT FOR THIS PROJECT

WHEREAS, the Madison County Fiscal Court ("County") desires to promote and carry out community development efforts on behalf of the residents of the county by supporting the HB 900 Project ("the Project"); and

WHEREAS, it is recognized that HB 900 monies available to the County for the purposes stated herein, pursuant to 2026 Kentucky General Assembly HB 900 (Appropriations Bill), impose certain obligations and responsibilities upon the County and will require among other things:

1. Approval of a satisfactory application transmitted to DLG for approval;
2. Registration with Finance & Administration Cabinet to do business with the Commonwealth; and,
3. Other obligations of the County in connection with receiving the HB 900 grant of monies for the purposes stated herein;

NOW, THEREFORE, BE IT RESOLVED THIS 26TH DAY OF MAY 2026 BY MADISON COUNTY FISCAL COURT:

That a HB 900 Project Grant Application on behalf of the County for HB 900 monies up to \$100,000.00 for Redeeming Hope Therapeutic Foster Home. Project shall be submitted to DLG; the County shall provide such additional information and furnish such documentation as may be required, and the County Judge/Executive shall act as the authorized correspondent for this Project.
