HONORABLE REAGAN TAYLOR COUNTY JUDGE EXECUTIVE PRESIDING

The Madison County Fiscal Court convened in special session on the 12th of May 2020 at 9:30AM via Zoom Video Conference. Present was the Honorable Reagan Taylor in the chair presiding and the following members of the Fiscal Court: Roger Barger, Larry Combs, Tom Botkin, and John Tudor were present. Madison County Attorney Jennie Haymond, Madison County Sheriff Mike Coyle, and Madison County Clerk Kenny Barger were also present.

It being determined a quorum was present, the meeting was called to order.

Magistrate Tudor led the court in prayer. Judge Taylor asked Sheriff Coyle to lead the Pledge of Allegiance.

IN RE: 2nd Reading Ord. 20-11—Amendment to 911 Interlocal Agreement:

Wendy Lynch, 911 Director, addressed the court for the 2nd reading of Ordinance 20-11, Amendment to 911 Interlocal Agreement. This agreement will allow one law enforcement agency to be designated as the criminal justice agency over Lincoln FDIC terminals. This agency will ensure everyone's certified, and that they have what they need in order to run queries. Lynch noted that having one central point of location will help when auditing from the state and FBI.
