HONORABLE REAGAN TAYLOR COUNTY JUDGE EXECUTIVE PRESIDING

The Madison County Fiscal Court convened in a special called session on the 31st of March 2026 at 1:00 PM in the Fiscal Courtroom of the Courthouse Annex Building in Richmond, Ky. Present was the Honorable Reagan Taylor in the chair presiding and the following members of the Fiscal Court: James Brian Combs, Stephen Lochmueller, Billy Ray Hughes, and Tom Botkin were present. Madison County Attorney Jennie Haymond, Madison County Sheriff Mike Coyle, and Madison County Clerk Kenny Barger were also present.

It being determined a quorum was present, the meeting was called to order.

Judge Taylor led the Court in prayer.

Judge Taylor asked Sheriff Mike Coyle to lead the Pledge of Allegiance.

IN RE: Resolution 2026-020 — Adoption of FY 2026-2027 Health Insurance Renewal Rates:

Jill Williams, Deputy Judge Executive, presented Resolution 2026-020 — Adoption of FY 2026-2027 Health Insurance Renewal Rates for the Court's approval. This is a Resolution of the Madison County Fiscal Court adopting the FY 2026-2027 Health Insurance Renewal Rates and Carriers.

Motion by Billy Ray Hughes seconded by James Brian Combs to approve Resolution 2025-020 — Adoption of FY 2026-2027 Health Insurance Renewal Rates.

Bud Carr, broker with Assured Partners, was in attendance for any questions the Court might have.

Jill explained that the medical, BluMine, vision, voluntary life, flexible spending, short-term disability, and all of the supplemental policies are all rate holds. For Delta Dental, they opted to increase the maximum benefit from \$1,000 to \$1,500 to cover more dental work for the employees that choose to have that dental program, which will increase that rate between \$2 and \$6 based on the chosen plan. Also, the basic life insurance increased less than \$2,800 in total for the Fiscal Court for the year.

Judge Taylor thanked Bud for all he has done for the County over the years.

Jill Williams, Deputy Judge Executive, presented Resolution 2026-021 — Shared Data Use Agreement for Mass Rabies Vaccinations Clinics for the Court's approval. This is a Resolution of the Madison County Fiscal Court relating to a shared data use agreement for mass rabies vaccination clinics with Madison County Health Department.

Motion by Billy Ray Hughes seconded by Stephen Lochmueller to approve Resolution 2026-021 — Shared Data Use Agreement for Mass Rabies Vaccinations Clinics.

Jill stated that they collaborate twice a year with the Health Department to perform the vaccination clinics.

Since they received a grant to do other vaccinations along with the rabies vaccinations, they will be sharing data with the Health Department to be able to use one form, and this agreement makes sure everything is used for the purpose of the mass vaccination clinics.

Judge Taylor asked Jill if they do micro-chipping at these clinics. Jill stated that they do. Jill explained that micro-chipping is for the benefit of the animals and the owners. If the pet gets lost, it is easier and quicker to

find them at a vet clinic, animal control, etc., and be reunited with the owners. Also, the microchip can do a lifetime dog license instead of having to renew that license every year.
